### **NOTICE OF RACE**

#### **ORGANISING AUTHORITY:**

The ONK A-cat 2011 will be organised by Hellecat under the auspice of the Dutch A-cat Association and in conjunction with the "watersportverbond".

#### **1.RULES:**

- The ONK A-cat 2011 will be governed by:
- The rules as defined in the Racing Rules of Sailing 2009-2012 (RRS) and any amendments.
- The prescriptions of the KBYV/FRBY. A boat, while racing, may display a national ensign or club burgee. This change the prescription of the KBYV/FRBY 77.
- If there is a conflict between languages the English text will take precedence.

#### **2.ADVERTISING:**

This event is designated to Category "C" according ISAF Regulation 20. Boats may be required to display advertising of the event sponsor on the forward 25% of each side of the hull. Such advertising, if any, shall be fixed in accordance with the Sailing Instructions.

#### **3.ELIGIBILITY AND ENTRIES:**

Entries shall be made at the Race Office when entering.  
Entries and non-refundable registration fees shall be received in Euro's.  
Any competitor under the age of 16 years has to deliver a written parental/guardian consent.

#### **4.EVENT FEES:**

The event fee is: € 75,-

Payments (in Euro only) shall be received on site registration, by cash.

### 6. MEASUREMENTS :

A boat or equipment may be inspected at any time for compliance with the class rules and sailing instructions. On the water, a boat can be instructed by a member of the race committee to proceed immediately to a designated area for inspection.

### 7. SAILING INSTRUCTIONS:

The Sailing Instructions will be available for each competitor at Friday 8<sup>th</sup> of July 2011 from 9:00 hr.

### 8. VENUE:

The ONK A-cat 2011 will be held at the Haringvliet, in front of "catamaranclub Club Hellecat".

### 9. COURSES AND COMPETITION FORMAT:

See sailing instructions

A total of 4 sailed races must be completed to validate ONK A cat 2011.

### 10. PENALTY SYSTEM:

10.1 Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe is required.

10.2 Decisions of the National Jury will be final as provided in rule 70.4.

### 11. SCORING SYSTEM:

The RRS Appendix A4.1 - Low Point Scoring system will be used.  
When 6 races have been completed, the worst score will be excluded.

### 12. DISCLAIMER OF LIABILITY:

Competitors participate entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the ONK A-cat 2011.

### 13. COMPETITOR'S INSURANCE:

All competitors entering one or more events as described in this N.O.R. shall have third party liability insurance with a minimum coverage of € 750,000.00.

### 14. RIGHT TO USE NAMES AND LIKENESS:

By sailing this event a competitor automatically grants to the Organising Authority and the sponsors of the event the right in perpetuity to make, use and show from time to time and at their discretion, any motion or still pictures, and live, taped or film television and any other reproductions of him/her during the period of The ONK A-cat 2011 in which the competitor competes and in all material related to The ONK A-cat 2011 without any compensation.
